Factual report of the meeting held at New Delhi

Inter Departmental Committee (IDC) for considering the proposals for Recognition of
Electrohomeopathy.

Dear Friends,

You all are aware about the happenings going on regarding above said subject since last 2 – 3 months.

Almost all EH Whatsapp Groups were silent on the matter till yesterday's meeting. But after the meeting, looking towards the positive attitude shown by majority of the IDC members, everybody started claiming that my or their proposal is approved/ranked No.1, having great impact and got positive signal to go ahead.

Dear friends, we ERDO never thought about benefit of our organization or any individual, but always thought in positive manner to take everyone under one roof for the betterment and thereby accreditation of Electrohomeopathic system of medicine as a whole.

In spite of ERDO's proposal selected at No.1 on its content's Merit and heard by all committee members without raising a single question. We are glad to let you know that, though ERDO's proposal was almost upto the perfection, we were always aware that there is a scope for further improvement. And keeping this view, only we have tried our level best to bring all first eight proposal holders together and discuss the proposals submitted on open platform so as to present one systematic, logical and perfect proposal in front of the committee. Unfortunately, others did not responded to this effort positively.

After ERDO effective ppt presentation, On subsequent presentations by other organizations, some of the lacunas and loopholes were caught by some of the honorable members of IDC and they threw series of questions which might have made our recognition at stake.

Fortunately committee chairman honorable Dr. Katoch was kind enough to give an opportunity for reply to these questions to all 29 organisations who had submitted proposals. So ERDO's representative Dr. Ajit Singh had replied most of the questions with effective substance and logical explanation which satisfied most of the committee member's queries.

Major obstacle was about relation between EH and Homeopathy, with misunderstandings such as:-

1. EH is a part of Homeopathy.
2. EH and Homeopathy are almost one and the same.

These wrong impression Were clarified by ERDO advisor Dr. Bahubali Shah (Former President of Maharashtra Council of Homeopathy) in a strong attacking way and claiming EH being as an Independent system of Medicine and having no relation with Homeopathy, giving reference of reports of the previous parliamentary committees, opinion of Central Council of Homeopathy on the issue recorded in 2003. Ultimately committee members from Central Council of Homeopathy(CCH) and Central Council of Research in homeopathy(CCRH) also confirmed Dr. Bahubali Shah's say.

During the presentation of one of the organiser's ppt committee member, Hon.Dr Talwar referring EH pharmacy as a part of GHP, put question whether EH can be added as part of Homoeopathy? Dr Ajit Singh replied that we don't have any objection but as the committee members from Homeopathic apex bodies, had already made some observations, Their view must be taken into consideration before discussing on this issue and both the committee members from CCH & CCRH bluntly registered strong objections for this, which stamped that EH HAS TO BE CONSIDERED AS AN INDEPENDENT SYSTEM OF MEDICINE FOR RECOGNITION.

Even after so much of positive happenings, the Hon. committee members were of the opinion that, few more documentation is needed before going further towards final decision.

Committee chairman, Honorable Dr Katoch, Suggested- instead of different organizations submitting documents separately, it will be convenient for them, if someone takes responsibility to coordinate all proposal holders and submit all documents asked for in one bunch. In response to this,ERDO representative Dr Ajit Singh stood up and showed his willingness to take this responsibility, all others agreed with appreciation and claps.

After conclusion of the meeting, representative of almost all organisations gathered in the premises and had discussion about submitting documents together. But some organizations showed contradictory view to that shown in the meeting and left without attending and some opposed for common submission of asked documents.

WE – ERDO HEREWITH CLARIFY OUR VIEW THAT WE ARE WORKING FOR THE ESTABLISHMENT AND BETTERMENT OF THE EH SYSTEM & NOT FOR ANY CREDIT. WE DO NOT HAVE ANY PREDUJICED VIEW ABOUT A INDIVIDUAL OR AN ORGANISATION. WE SINCERELY APPEAL TO ALL EH WORKERS AND ORGANISATIONS TO COOPERATE AND KEEP UNITY, COME FORWARD WITH WHATEVER DOCUMENTS YOU HAVE WHICH WILL HELP IN RECOGNISATION OF OUR EH SYSTEM.

ANYWAY 'ERDO' WILL NEVER RUN AWAY FROM THE RESPONSIBILITY AND WILL DEFINITELY GATHER AND SUBMIT THE REQUIRED DOCUMENTS SO AS FOR EH TO BE RECOGNISED AS OFFICIAL SYSTEM OF MEDICINE.

'ERDO' ONCE AGAIN REATTURATE THAT INTER DEPARTMENTAL EXPERT COMMITTEE IS GOING TO SUBMIT RECOMMENDATIONS ABOUT RECOGNISATION OF EH AS A SYSTEM OF MEDICINE. IT WON'T BE EITHER APPROVAL OR DENIAL OF ANY INDIVIDUAL PROPOSAL. SO IT WILL BE EITHER VICTORY OR DEFEAT OF ALL OF US.

WE HOPE EVERYBODY CONNECTED WITH EH WILL READ THIS, THINK ABOUT THIS AND ACT ACCORDING TO THEIR CONCIOSNESS.
